Ref: Proposed initial public offering of equity shares of face value of ₹10 each (the "Equity Shares") of Afcons Infrastructure Limited (the "Company", and such initial public offering, the "Offer")

Dear Sir/ Madam,

This is with reference to the draft red herring prospectus dated March 28, 2024 ("DRHP") of the Company, filed with the Securities and Exchange Board of India ("SEBI"), BSE Limited ("BSE") and National Stock Exchange of India Limited ("NSE", and together with BSE, the "Stock Exchanges"). SEBI, pursuant to its observations, requires the Company to intimate and inform the RoC about certain missing corporate records which were filed by the Company with the RoC, among other things.

It is submitted that the following corporate records and forms filed by the Company with the RoC are untraceable, either at the Ministry of Corporate Affairs portal at www.mca.gov.in (the "MCA Portal"), the records physically available at the office of the RoC or in the records maintained by the Company:

Further, in addition to the missing corporate records which were filed with the RoC as mentioned in the table above, there are certain inaccuracies and discrepancies in: (i) the details of the allottees in relation to the initial subscription, *i.e.*, the subscription clause of the memorandum of association of the Company ("MoA") does not reflect that the equity shares of the Company allotted to George Kuckelmann were held by him as a registered owner on behalf of M/s. Rodio Foundation Engineering Limited Zurich, which was the beneficial owner of such equity shares; and (ii) the list of allottees attached in the Form 2 filed for the allotment of 19,990 equity shares of the Company on March 18, 1977, of which 13,500 equity shares of the Company (including the 10 equity shares of the Company allotted to George Kuckelmann on behalf of M/s. Rodio Foundation Engineering Limited Zurich) were allotted to M/s. Rodio Foundation Engineering Limited Zurich as a subscriber to the MoA.

In relation to the aforementioned missing corporate records which were filed by the Company with the RoC, the Company had engaged S. N. Ananthasubramanian & Co., Independent Practising Company Secretary (having peer review certificate bearing number 606/2019), who had provided the certificate dated March 28, 2024, attached herewith as **Schedule I**, confirming that the aforementioned documents are untraceable, based on their: (i) independent search/inspection of documents available in the digital records maintained on the MCA Portal; (ii) physical search at the RoC office in Navi Mumbai; and (iii) review of the documents and records available with the Company.

We request you to take this letter on record.

This letter may be submitted with SEBI and any other statutory or regulatory authority, as may be required, and shall be made available for public inspection in connection with the Offer.
