#### FPIs sell equities worth ₹26.5K cr in Nov, so far

Foreign investors have pulled out ₹26,533 crore from the Indian equity market this month so far owing to increasing allocations to China, concerns over muted corporate earnings and elevated valuation of domestic stocks. While the sell off continues, the quantum of net outflows has significantly reduced compared to October, when foreign portfolio investors (FP) withdrew ₹94,017 crore (\$11.2 billion) on a net basis. With the latest pull-out, FPI outflows on a net basis are ₹19940 crore in 2024 s (£1.2 billion).
